The Red Rock Community Center (RRCC, hereinafter “Center or facility”) is a nonprofit entity of the RRCC, Incorporated organization; and is maintained by the RRCC Board of Directors (“Board”), Members, and contributing community. This Agreement is for **RRCC Members’ Group** usage of the Center’s **outside Grounds only**, including the Pavilion & Covered Shelter.

The following requirements must be met prior to your reservation being confirmed:

[However, registrations made **after** the Early Entry Date will incur an additional **\$5 late fee** and All must **provide the following upon entry and prior to setup**]:

- A **check or money order** for the Board approved **Usage Fee** to be mailed to the PO Box mailing address listed above, along with this **signed Usage Agreement**. Reference the last page of this Agreement for the **Usage Fee** based on the “Location Requested” for this event.
- The Responsible Party/Parties signing this Agreement must agree to all set forth terms and conditions, and be a **paid RRCC Corporation Member**. Membership Dues are **\$15** annually (January 1 – December 31). If you have not paid Membership for the calendar year, include **Dues** and submit a **Membership Application**, with this Agreement. If more than one person will be responsible for meeting any of these terms and conditions, **all Parties** need to sign this Agreement and be paid Members/submit Membership Application(s). The Center is a family-oriented facility and your event must be conducted with respect for our historic building and the surrounding community.

The following is prohibited/requirements at the Center:

- No open Fires allowed on the grounds or in the building, i.e. campfires, candles.
- No illegal activities of any kind.
- No usage of Center’s inside Tables and Chairs is allowed.
- Use of the Outdoor Pavilion & tin Covered Shelter are available on a first-come-first-available basis. **All should anticipate bringing your own setups** (i.e. tables, chairs, popup shading); and removal of such upon final cleanup/before leaving, **no permanent setups** without Board approval. A reminder to please bring bug spray, etc. as wasps and ants are frequently seen on the outside Grounds.
- The outside Fenced Area behind and to the front-left side of the Center may be used **only if no other area is available**; however, if this area is used **no driving** is allowed within this fenced area as it protects the waterlines & septic system.

Indemnification for Liability:

Responsible Party/Parties (hereinafter “Party’s”) shall protect, defend, indemnify, and hold harmless Red Rock Community (RRCC) Incorporated organization or any agent thereof, from any damages, costs, attorney’s fees or expenses arising from Party’s product liability, negligence, gross negligence, or intentional acts in connection with Party’s use of the RRCC facilities. In addition, Responsible Party/Parties shall protect, defend, indemnify, and hold harmless RRCC Incorporated organization or any agent thereof, from any damages, costs, attorney’s fees or expenses arising from product liability, negligence, gross negligence, or intentional acts of any of Party’s guests in connection with use of the RRCC facilities.

Responsible Party/Parties acknowledge(s) by signing below that he/she has read this contract in its entirety, that he/she is/are the responsible party(ies) for held event(s), and that he/she will abide by the guidelines and rules in this contract. The Party(ies) understand(s) that failure to follow these guidelines and rules can result in assessment of additional fees. Any damages to the facility may also result in fees assessed for the cost of repairs. RRCC Board retains the right to cancel any event that has been misrepresented or any event which becomes one considered harmful to the community and its residents.
